<u>Minutes</u> -- Reading and approval of Minutes from August 21, 2019. Tony R. made motion to accept minutes without corrections, Seconded. Motion passed.

<u>Financial Report</u> -- Review of all accounts for Chief's Association. Lee C. asked when we pay dues. Gus said in January.

<u>Guest Speakers/Seasonal Updates</u> – Wildland Season – Jason W. relayed fire danger went to moderate on Sept. 9th. Provided information on burn permits available and that open burn season starts on October 20th. Provided some statistics for 2019 season – 18 fires and 12.5 acres. Announced that the IDL is looking to provide FFT2 & FFT1 training next spring if the fire departments have the numbers and interest in attending. Wildland Season – Lee C. – Average number of fires and slow nationally all season.

<u>Honor Guard Committee Updates</u> -- Len Pine – Honor guard is reconvening for the fall. Looking to have 2 personnel to do high school flag raising events i.e. football games. Have purchased a casket flag. <u>Fire Prevention Co-Op Updates</u> – Jason W. – Continuing to work on home assessments and finishing up on the last of the names from the fair sign-up.

Gus – Moving forward with the effort to assist Red Cross with distributing free smoke detectors in Boundary County. Ken H. has prepared a letter to be distributed to kids in grades K-5 along with a signup sheet for smoke detectors and wildland fire home assessment. Discussion on liability installing detectors and wear/tear when enter houses.

New Business

- Color Guard or Honor Guard (Is Color Guard Needed) Len P. Following the • turned down of an event that did not follow SOPs or align with Honor Guard's mission, there was talk of creating a Color Guard. Honor Guard – honoring the fallen; whereas, Color Guard - presenting the colors (flag) at events. Discussed possibilities of separate uniforms, trainings and how to pay for new uniforms/equipment. Mike E. – asked if Honor Guard or Color Guard could charge for events. Len P. responded that they don't unless it is to cover travel costs. Tony R. ask if there would be confusion as to which Guard would respond to requested events. Gus responded that Honor Guard should be only for memorial services whereas Color Guard can raise the flag at other events. Len P. - willing to propose a Color Guard but would like to recruit someone to head up the trainings. Discussion on 'Is Color Guard a group that is wanted?' – Dave W. suggested that the agencies be solicited for members/volunteers. Discussion on number of events, training and time commitment. Anticipating: (Minimum of 2 persons per event. Training every other Friday from 6-8PM. More events to cover than Honor Guard). Gus revisited reaching out to agencies for volunteers.
- <u>BCFCA Co-Op Bylaws –</u> Gus J. Passed out copies of proposed bylaws. Brief period to review and Tony J. motioned to approve. Brad S. seconded. Vote to approve: majority ayes and none apposed. Motion to approve passed.
- <u>9/11 Memorial for 2020 –</u> Gus J. Discussion about possible events for next year to expand ceremony. Len P. provided recap of this year's ceremony process. Gus asked Len to create a program for next year's 9/11 memorial service.
- <u>Elections in November –</u> Gus J. Elections coming up in November... think about it.
